## A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Law – Death Penalty – Mass Murder**  
3 **(Capital Gazette Shooting Memorial Act)**

4 FOR the purpose of providing that a person who is convicted of first-degree murder may  
5 be sentenced to death under certain circumstances; providing that a certain mass  
6 murder under certain circumstances constitutes an aggravating circumstance that  
7 the court or jury must consider in making a determination as to the imposition of the  
8 death penalty; establishing certain procedures relating to custody, warrant of  
9 execution, incompetency, method of execution, witnesses, certificate, disposition of  
10 body, notice, and trial and sentencing in relation to the imposition of the death  
11 penalty; requiring the Division of Correction to complete a presentence investigation  
12 report in each case in which the death penalty was requested under a certain  
13 provision of law; providing that the juvenile court does not have jurisdiction over a  
14 child of a certain age alleged to have done an act that, if committed by an adult,  
15 would be a crime punishable by death, as well as lead to certain other charges, unless  
16 a certain order has been filed; providing that the juvenile court may waive the  
17 exclusive jurisdiction conferred by a certain provision of law with respect to a petition  
18 alleging delinquency by a child who has not reached a certain age but who is charged  
19 with committing an act that, if committed by an adult, would be punishable by death;  
20 authorizing a trial judge to strike an individual from a jury on the basis of the  
21 individual's belief for or against capital punishment only if the judge finds that the  
22 belief would prevent or substantially impair the individual from returning an  
23 impartial verdict according to law; providing that an individual struck from a jury  
24 under a certain provision of law may serve on another jury for which the basis for  
25 the strike is irrelevant; applying a certain provision of law relating to peremptory  
26 challenges to a criminal trial in which a defendant is subject, on any single count, to  
27 a death sentence because the State has given a certain notice of intention to seek a  
28 death sentence or a sentence of imprisonment for life, including a case in which the  
29 State has not given a certain notice of intention to seek a death sentence; providing  
30 that a certain provision of law authorizing a court that issued an execution on a

1 forfeited recognizance for a certain witness to discharge the witness from execution  
2 on a certain motion does not apply in a case if capital punishment may be involved;  
3 providing that the Court of Appeals has exclusive appellate jurisdiction over a  
4 criminal case in which the death penalty is imposed and any appellate proceeding  
5 under a certain provision of law relating to certain incompetent inmates; requiring  
6 a court to dismiss a certain charge against a certain defendant found incompetent to  
7 stand trial if charged with a capital offense after a certain number of years;  
8 prohibiting the release of a defendant on personal recognizance if the defendant is  
9 charged with a crime punishable by death; applying the Uniform Postconviction  
10 Procedure Act to a person convicted in any court in the State who is confined under  
11 sentence of death; adding certain provisions to the Uniform Postconviction Procedure  
12 Act for proceedings after death sentences; specifying that the review of a sentence of  
13 death is governed by certain provisions of law; prohibiting a review panel from  
14 increasing a sentence to the sentence of death; providing that a victim's  
15 representative has the same right to address the jury in a death penalty sentencing  
16 as a victim's representative has to address a court in a certain other sentencing or  
17 disposition hearing; creating certain procedures relating to the determination of  
18 whether a victim's representative may present an oral address to the jury in a death  
19 penalty sentencing; authorizing the Court of Appeals to adopt rules of procedure to  
20 govern the conduct of death penalty sentencing proceedings; establishing certain  
21 procedures for the review of a death sentence by the Court of Appeals; providing that  
22 certain provisions of law relating to multiple convictions for a crime of violence do  
23 not apply if a person is sentenced to death; creating certain exceptions; making  
24 conforming, stylistic, and clarifying changes; and generally relating to the death  
25 penalty.

32 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
33 That the Laws of Maryland read as follows:

35 **SUBTITLE 9. DEATH PENALTY PROCEDURES.**

36 **3–901.**

37 **(A) WHENEVER AN INDIVIDUAL IS SENTENCED TO DEATH, THE JUDGE OF**

1 THE COURT IN WHICH THE CONVICTION TAKES PLACE SHALL CAUSE THE  
2 INDIVIDUAL TO BE TAKEN INTO CUSTODY BY THE SHERIFF OF THE COUNTY IN WHICH  
3 THE INDIVIDUAL WAS INDICTED.

4 (B) (1) WHILE AN INMATE IS IN THE CUSTODY OF THE SHERIFF, THE  
5 SHERIFF SHALL:

6 (I) HOLD THE INMATE UNDER GUARD AS THE SHERIFF  
7 DETERMINES TO BE NECESSARY; AND

8 (II) KEEP THE INMATE IN SOLITARY CONFINEMENT IN THE SAME  
9 MANNER AS IS REQUIRED WHEN THE INMATE IS IN THE CUSTODY OF THE  
10 DEPARTMENT.

11 (2) AS SOON AS POSSIBLE, THE SHERIFF SHALL DELIVER THE INMATE  
12 TO THE DEPARTMENT TO AWAIT THE EXECUTION OF THE INMATE'S SENTENCE.

13 (C) THE EXPENSES OF THE DEPARTMENT RELATING TO THE DETENTION OF  
14 AN INMATE UNDER SENTENCE OF DEATH, INCLUDING THE EXPENSES OF GUARDING,  
15 LODGING, FEEDING, CLOTHING, AND CARING FOR THE INMATE, MAY NOT BE  
16 ASSESSED AGAINST, BILLED TO, OR PAID BY THE COUNTY IN WHICH THE INMATE WAS  
17 INDICTED.

19 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS  
20 INDICATED.

21 (2) (I) "STATE POSTCONVICTION REVIEW PROCESS" MEANS THE  
22 INITIAL ADJUDICATION OF A POSTCONVICTION PETITION FILED UNDER §  
23 7-103 OF THE CRIMINAL PROCEDURE ARTICLE, INCLUDING ANY APPELLATE  
24 REVIEW OF THE POSTCONVICTION PROCEEDING.

25 (II) "STATE POSTCONVICTION REVIEW PROCESS" DOES NOT  
26 INCLUDE:

27 1. A POSTCONVICTION PROCEEDING THAT HAS BEEN  
28 REOPENED UNDER § 7-104 OF THE CRIMINAL PROCEDURE ARTICLE OR ANY  
29 APPELLATE REVIEW OF THE PROCEEDING; OR

30 2. A POSTCONVICTION PROCEEDING ON A SECOND  
31 PETITION FILED BEFORE OCTOBER 1, 1995, OR ANY APPELLATE REVIEW OF THE  
32 PROCEEDING.

1           **(3) “WARRANT OF EXECUTION” MEANS A WARRANT FOR THE**  
2 **EXECUTION OF A SENTENCE OF DEATH ON THE INDIVIDUAL AGAINST WHOM THE**  
3 **SENTENCE WAS IMPOSED.**

4           **(B) A WARRANT OF EXECUTION SHALL:**

5                 **(1) STATE THE CONVICTION AND SENTENCE;**

6                 **(2) DESIGNATE A 5-DAY PERIOD, BEGINNING ON A MONDAY, WITHIN**  
7 **WHICH THE SENTENCE MUST BE EXECUTED; AND**

8                 **(3) COMMAND THE SECRETARY TO CARRY OUT THE DEATH PENALTY**  
9 **ON A DAY WITHIN THE DESIGNATED PERIOD.**

10           **(C) AT THE TIME AN INDIVIDUAL IS SENTENCED TO DEATH, THE JUDGE**  
11 **PRESIDING IN THE COURT SHALL ISSUE A WARRANT OF EXECUTION DIRECTED TO**  
12 **THE SECRETARY.**

13           **(D) (1) A WARRANT OF EXECUTION IS STAYED DURING THE DIRECT**  
14 **REVIEW PROCESS AND THE STATE POSTCONVICTION REVIEW PROCESS.**

15                 **(2) IF THE ORIGINAL WARRANT OF EXECUTION HAS NOT EXPIRED AT**  
16 **THE END OF THE STATE POSTCONVICTION REVIEW PROCESS, THE JUDGE WHO**  
17 **IMPOSED THE SENTENCE OF DEATH OR THE JUDGE THEN PRESIDING IN THE COURT**  
18 **IN WHICH THE SENTENCE WAS IMPOSED SHALL LIFT THE STAY IMPOSED UNDER**  
19 **PARAGRAPH (1) OF THIS SUBSECTION.**

20                 **(3) IF THE ORIGINAL WARRANT OF EXECUTION HAS EXPIRED AT THE**  
21 **END OF THE STATE POSTCONVICTION REVIEW PROCESS, THE JUDGE WHO IMPOSED**  
22 **THE SENTENCE OF DEATH OR THE JUDGE THEN PRESIDING IN THE COURT IN WHICH**  
23 **THE SENTENCE WAS IMPOSED SHALL ISSUE ANOTHER WARRANT OF EXECUTION.**

24           **(E) (1) IF THE GOVERNOR IS SATISFIED THAT A MEDICAL EXAMINATION**  
25 **SHOWS THAT AN INMATE IS PREGNANT, THE GOVERNOR SHALL REVOKE A WARRANT**  
26 **OF EXECUTION FOR THE INMATE.**

27                 **(2) AS SOON AS THE GOVERNOR IS SATISFIED THAT THE INMATE IS**  
28 **NO LONGER PREGNANT, THE GOVERNOR PROMPTLY SHALL ISSUE ANOTHER**  
29 **WARRANT OF EXECUTION.**

30           **(F) (1) THE GOVERNOR MAY GRANT A STAY OF A WARRANT OF**  
31 **EXECUTION FOR ANY CAUSE.**

1           **(2) IF THE GOVERNOR GRANTS A STAY UNDER THIS SUBSECTION:**

2                   **(I) THE GOVERNOR SHALL ISSUE AN ORDER REVOKING THE**  
3 **WARRANT OF EXECUTION; AND**

4                   **(II) THE SENTENCE OF DEATH MAY NOT BE EXECUTED UNTIL**  
5 **THE GOVERNOR ISSUES ANOTHER WARRANT OF EXECUTION.**

6           **(3) THE GOVERNOR PROMPTLY SHALL NOTIFY THE SECRETARY OF**  
7 **AN ORDER THAT REVOKES A WARRANT OF EXECUTION.**

8           **(G) (1) THE SECRETARY SHALL SET A TIME, WITHIN THE PERIOD**  
9 **DESIGNATED IN THE WARRANT OF EXECUTION, WHEN THE SENTENCE OF DEATH**  
10 **SHALL BE EXECUTED.**

11           **(2) NO PREVIOUS ANNOUNCEMENT OF THE DAY OR TIME OF THE**  
12 **EXECUTION MAY BE MADE EXCEPT TO THOSE WHO ARE INVITED OR ALLOWED TO BE**  
13 **PRESENT AS PROVIDED IN THIS SUBTITLE.**

15           **(A) IN THIS SECTION, "OFFICIAL" MEANS:**

16                   **(1) THE SECRETARY; OR**

17                   **(2) THE SHERIFF OF THE COUNTY IN WHICH AN INMATE WAS**  
18 **INDICTED.**

19           **(B) (1) IF THE GOVERNOR GRANTS A REPRIEVE TO AN INMATE UNDER**  
20 **SENTENCE OF DEATH OR A COURT IMPOSES A STAY ON THE EXECUTION OF A**  
21 **SENTENCE OF DEATH, THE GOVERNOR OR THE COURT SHALL SERVE NOTICE OF THE**  
22 **REPRIEVE OR STAY ON:**

23                   **(I) THE INMATE; AND**

24                   **(II) THE OFFICIAL WHO HAS CUSTODY OF THE INMATE.**

25           **(2) THE OFFICIAL WHO HAS CUSTODY OF THE INMATE SHALL OBEY**  
26 **THE REPRIEVE OR STAY.**

27           **(C) AN INMATE WHO IS GRANTED A REPRIEVE OR STAY SHALL REMAIN IN**  
28 **THE CUSTODY OF THE OFFICIAL WHO RECEIVES NOTICE UNDER SUBSECTION**

1 (B)(1)(II) OF THIS SECTION.

2 (D) (1) IN ANY SUBSEQUENT JUDICIAL PROCEEDING, THE COURT SHALL  
3 SERVE ANY COURT ORDER REGARDING AN INMATE ON:

4 (I) THE INMATE; AND

5 (II) THE OFFICIAL WHO HAS CUSTODY OF THE INMATE.

6 (2) IF A COURT RESENTENCES AN INMATE TO DEATH, THE  
7 PROVISIONS OF THIS SUBTITLE SHALL APPLY TO THE NEW SENTENCE IN THE SAME  
8 MANNER AS THE ORIGINAL SENTENCE.

9 (3) (I) IF A NEW TRIAL IS GRANTED TO AN INMATE WHO IS IN THE  
10 CUSTODY OF THE SECRETARY, THE INMATE SHALL BE TRANSPORTED BACK TO THE  
11 PLACE OF TRIAL UNDER GUARD AS THE SECRETARY DIRECTS.

12 (II) THE EXPENSES RELATING TO THE TRANSPORTATION OF AN  
13 INMATE BACK TO THE PLACE OF TRIAL UNDER SUBPARAGRAPH (I) OF THIS  
14 PARAGRAPH SHALL BE PAID BY THE DEPARTMENT.

17 INDICATED.

18 (2) "INCOMPETENT" MEANS THE STATE OF MIND OF AN INMATE WHO,  
19 AS A RESULT OF A MENTAL DISORDER OR AN INTELLECTUAL DISABILITY, LACKS  
20 AWARENESS:

21 (I) OF THE FACT OF THE INMATE'S IMPENDING EXECUTION;  
22 AND

23 (II) THAT THE INMATE IS TO BE EXECUTED FOR THE CRIME OF  
24 MURDER.

25 (3) "INMATE" MEANS AN INDIVIDUAL WHO HAS BEEN CONVICTED OF  
26 MURDER AND SENTENCED TO DEATH.

27 (B) AN INMATE IS NOT INCOMPETENT UNDER THIS SECTION MERELY  
28 BECAUSE THE INMATE'S COMPETENCE DEPENDS ON CONTINUING TREATMENT,  
29 INCLUDING THE USE OF MEDICATION.

1           **(C) THE STATE MAY NOT EXECUTE A SENTENCE OF DEATH AGAINST AN**  
2 **INMATE WHO HAS BECOME INCOMPETENT.**

3           **(D) (1) A PETITION THAT ALLEGES THAT AN INMATE IS INCOMPETENT**  
4 **AND THAT SEEKS TO REVOKE A WARRANT OF EXECUTION AGAINST THE INMATE MAY**  
5 **BE FILED BY:**

6                           **(I) THE INMATE;**

7                           **(II) IF THE INMATE IS REPRESENTED BY COUNSEL, COUNSEL**  
8 **FOR THE INMATE; OR**

9                           **(III) IF THE INMATE IS NOT REPRESENTED BY COUNSEL, ANY**  
10 **OTHER PERSON ON THE INMATE'S BEHALF.**

11                   **(2) THE PETITION SHALL BE FILED IN THE CIRCUIT COURT OF THE**  
12 **COUNTY IN WHICH THE INMATE IS CONFINED.**

13                   **(3) ON THE FILING OF THE PETITION, THE COURT MAY STAY ANY**  
14 **WARRANT OF EXECUTION THAT WAS ISSUED PREVIOUSLY AND HAS NOT YET**  
15 **EXPIRED.**

16                   **(4) THE PETITION MUST BE ACCOMPANIED BY AN AFFIDAVIT OF AT**  
17 **LEAST ONE PSYCHIATRIST THAT:**

18                           **(I) IS BASED, AT LEAST IN PART, ON PERSONAL EXAMINATION;**

19                           **(II) STATES THAT, IN THE PSYCHIATRIST'S MEDICAL OPINION,**  
20 **THE INMATE IS INCOMPETENT; AND**

21                           **(III) STATES THE PERTINENT FACTS ON WHICH THE OPINION IS**  
22 **BASED.**

23                   **(5) A COPY OF THE PETITION SHALL BE SERVED ON THE ATTORNEY**  
24 **GENERAL AND THE OFFICE OF THE STATE'S ATTORNEY THAT PROSECUTED THE**  
25 **INMATE, IN ACCORDANCE WITH THE SERVICE REQUIREMENTS OF THE MARYLAND**  
26 **RULES.**

27                   **(6) UNLESS THE INMATE IS ALREADY REPRESENTED BY COUNSEL,**  
28 **THE COURT PROMPTLY SHALL APPOINT A PUBLIC DEFENDER OR, IF THE PUBLIC**  
29 **DEFENDER FOR GOOD CAUSE DECLINES REPRESENTATION, OTHER COUNSEL TO**  
30 **REPRESENT THE INMATE IN THE PROCEEDING.**



1           **(7) UNLESS THE STATE'S ATTORNEY STIPULATES THAT THE INMATE**  
2 **IS INCOMPETENT, THE STATE'S ATTORNEY SHALL CAUSE THE INMATE TO BE**  
3 **EXAMINED AND EVALUATED BY ONE OR MORE PSYCHIATRISTS SELECTED BY THE**  
4 **STATE'S ATTORNEY.**

5           **(8) IF THE INMATE'S PETITION IS REASONABLE AND MADE IN A**  
6 **TIMELY MANNER, THE INMATE IS ENTITLED TO BE INDEPENDENTLY EXAMINED BY A**  
7 **PSYCHIATRIST THAT THE INMATE SELECTS.**

8           **(9) UNLESS, WITH THE COURT'S APPROVAL, THE PARTIES WAIVE A**  
9 **HEARING, THE ADMINISTRATIVE JUDGE OF THE COURT SHALL DESIGNATE A TIME**  
10 **FOR AN EVIDENTIARY HEARING TO DETERMINE THE INMATE'S COMPETENCE.**

11           **(E) (1) A HEARING UNDER THIS SECTION SHALL BE HELD WITHOUT A**  
12 **JURY:**

13                   **(I) IN COURT;**

14                   **(II) AT THE PLACE WHERE THE INMATE IS CONFINED; OR**

15                   **(III) AT ANOTHER CONVENIENT PLACE.**

16           **(2) AT THE HEARING, AN INMATE:**

17                   **(I) SUBJECT TO REASONABLE RESTRICTIONS RELATED TO THE**  
18 **INMATE'S CONDITION, MAY BE PRESENT;**

19                   **(II) THROUGH COUNSEL, MAY OFFER EVIDENCE,**  
20 **CROSS-EXAMINE WITNESSES AGAINST THE INMATE, AND MAKE ARGUMENT; AND**

21                   **(III) HAS THE BURDEN OF ESTABLISHING INCOMPETENCE BY A**  
22 **PREPONDERANCE OF THE EVIDENCE.**

23           **(F) THE COURT SHALL ENTER AN ORDER THAT:**

24                   **(1) DECLARES AN INMATE TO BE EITHER COMPETENT OR**  
25 **INCOMPETENT; AND**

26                   **(2) STATES THE FINDINGS ON WHICH THE DECLARATION IS BASED.**

27           **(G) IF THE COURT FINDS AN INMATE TO BE COMPETENT, THE COURT**  
28 **IMMEDIATELY:**

1           **(1) SHALL LIFT ANY STAY OF A WARRANT OF EXECUTION THAT WAS**  
2 **ISSUED PREVIOUSLY AND HAS NOT YET EXPIRED; OR**

3           **(2) IF ALL PREVIOUSLY ISSUED WARRANTS OF EXECUTION HAVE**  
4 **EXPIRED, SHALL NOTIFY THE COURT THAT IMPOSED THE SENTENCE OF DEATH AND**  
5 **REQUEST THAT THE COURT ISSUE A NEW WARRANT OF EXECUTION.**

6           **(H) (1) IF THE COURT FINDS AN INMATE TO BE INCOMPETENT, THE**  
7 **COURT SHALL:**

8                   **(I) STAY ANY WARRANT OF EXECUTION THAT WAS ISSUED**  
9 **PREVIOUSLY AND HAS NOT YET EXPIRED; AND**

10                   **(II) REMAND THE CASE TO THE COURT IN WHICH THE SENTENCE**  
11 **OF DEATH WAS IMPOSED.**

12           **(2) THE COURT IN WHICH THE SENTENCE OF DEATH WAS IMPOSED**  
13 **SHALL STRIKE THE SENTENCE OF DEATH AND ENTER IN ITS PLACE A SENTENCE OF**  
14 **IMPRISONMENT FOR LIFE WITHOUT THE POSSIBILITY OF PAROLE.**

15           **(3) THE SENTENCE OF IMPRISONMENT FOR LIFE WITHOUT THE**  
16 **POSSIBILITY OF PAROLE IMPOSED UNDER PARAGRAPH (2) OF THIS SUBSECTION IS**  
17 **MANDATORY AND MAY NOT BE SUSPENDED WHOLLY OR PARTLY.**

18           **(I) (1) THERE IS NO RIGHT OF APPEAL FROM AN ORDER ISSUED BY A**  
19 **CIRCUIT COURT UNDER THIS SECTION.**

20           **(2) NOTWITHSTANDING PARAGRAPH (1) OF THIS SUBSECTION,**  
21 **EITHER PARTY MAY SEEK REVIEW IN THE COURT OF APPEALS BY FILING AN**  
22 **APPLICATION FOR LEAVE TO APPEAL IN ACCORDANCE WITH THE MARYLAND**  
23 **RULES.**

24           **(3) IF AN APPLICATION FOR LEAVE TO APPEAL IS FILED, THE COURT**  
25 **OF APPEALS MAY STAY ANY WARRANT OF EXECUTION THAT WAS ISSUED**  
26 **PREVIOUSLY AND HAS NOT EXPIRED.**
